I. Application

Distance meter according to the new national standard development and professional production from. 2. Technical parameter:

Maximum mark distance :400mm,

40 marks can be made for each shake.

Marks distance is 10mm (5mm punctuation distance can be achieved by misplacement dot)

Error is not more than $\pm 0.15\text{mm}$,

The full length is divided into 300mm and 400mm mark tips,

Made of ball bearing round steel, the hardness is not less than RC55 .
